General Terms of Publication in *The Luventicus Academy Reports*

Adviser Warranties

- The adviser assert the moral right to be considered an expertise in the field of interest.
- The adviser has a positive opinion about the method employed by the author.

Understandings

- Luventicus has established an official advice-acceptance procedure of the work, where quality is to be maintained through review of expertises suggested by the author for the employed method, general interest, and relations to the *Reports* scope.
- All works submitted to Luventicus are subject to advice-acceptance, a process that is the responsibility of the Editors.
- The adviser is a person having the power to recommend. This power comes from his position in an academic institution, his previous publication of works in the field, or the general reconnaissance of his contributions in the area of interest.
- The adviser give his positive opinion about: the coincidence of the work scope with the ones of *Reports*, the validity of the employed methods, the clarity of explanations (for people working in the corresponding area), and the use of an appropriate tone for *Reports*; but he is not a referee, i.e. a person who judges the importance or the conclusions of the work.
- All readers can express their opinions on the published works in the Comments section or in the Online Forum. This comments and opinions will be available together with the work in our site. Thus, the evaluation or recognition of a work is not a job for few persons: is a work for *Reports* readers.
- Luventicus will communicate opinions and (re)interpretations of any topic published in *Reports*, if they are given in a polite, constructive manner.
- *Reports* is a publication intended to meet quality standards comparable to those of refereed journals.
- *Reports* may contain works and analysis of works done by authors around the world which, for technical reasons, are unsuitable for publications in the regular literature due to, for instance, excessive length, excessive tabular material, excessive detail of computer routines, excessive detail of instrumental descriptions, etc.
